That BCSTA...advocates/requests/encourages/urges (all of those) the Ministry of Health, Ministry of Children and Family Development, Ministry of Education to address wait times for assessments for children who have been identified with neurodiversity such as ASD, ADHD, FASD, and SPD in the public education system. These assessments are necessary to address inequity in the public education system, access to appropriate interventions and quality education.

Rationale

Provide a <u>succinct</u> description of why this motion is needed, plus any relevant background information.

This motion is needed because wait times for neuro-diverse assessments continue to be a barrier for appropriate intervention and support for our students. For example in the Northern Health Region in August 2019 the wait time for an ASD assessment was 16 months from the time of referral. Currently, in January 2021 the wait time is 24 months from the time of referral. For ADHD, SPD and FASD the wait times for assessment are 14-16 months. Parents in our region can seek private assessments at significant cost to them through clinics in the lower mainland and one in the Okanagan. There continues to be capacity challenges in the availability of professionals to assess these children in a timely fashion. In order for these children to have the best outcome we can provide them early assessment, diagnosis and intervention is vital.
